Requests

Field Name	Description
Summary	A brief description of the request
Priority	Urgency of the request, whether Critical, High, Medium, or Low
Contact	The contact for whom the request is being created
Company	The company associated with the contact
Email	The email of the contact
Service Address Name	The address of the contact's location where the service task needs to be carried out
Billing Address Name	The address for billing and invoicing
Phone	The contact phone number
Preferred Slot	The preferred time when they would like the service to be rendered
Preferred Start Time	The start time of a specific preferred time
Preferred End Time	The end time of a specific preferred time
Preference	Any additional requirements regarding the request
Due Date	The date by which the request must be closed
Asset	The asset associated with the request, if any

Field Name	Description
Summary	A brief description of the estimate
Request	The request associated with the estimate
Expiry Date	A date until which the estimate will be valid
Contact	The contact for whom the estimate is being created
Company	The company associated with the contact
Email	The email of the contact
Service Address Name	The address of the contact's location where the service task needs to be carried out

Billing Address Name	The address for billing and invoicing
Phone	The contact phone number
Asset	The asset associated with the estimate, if any
Service Name	The services that have to be delivered for the request that the estimate is being created for
Service Quantity	The amount of work associated with the service
Service List Price	The price of the service
Service Discount	Discount available on the price of the service, if any

Summary	A brief description of the estimate

Contact	The contact for whom the estimate is being created
Company	The company associated with the contact
Email	The email of the contact
Service Address Name	This is the address of the contact's location where the service task needs to be carried out
Billing Address Name	The address for billing and invoicing
Phone	The contact phone number
Preferred Slot	The Preferred time when they would like the service to be rendered
Preferred Start Time	The start time of a specific preferred time
Preferred End Time	The end time of a specific preferred time
Preference	Any additional requirements regarding the request
Due Date	The date by which the work order should be closed
Asset	The asset associated with the work order, if any

Asset Name	The name of the asset
Asset Number	Any serial number associated with the asset
Product	The product with which the asset is associated
GIAI	A global individual asset identifier code
Description	A description of the asset
Purchased Date	Date when the asset was purchased
Installation Date	Date of installation of the asset
Ordered Date	Date when the asset was ordered
Warranty Expiration	Date when the warranty of the asset will expire
Company	The company associated with the contact
Contact	The contact for whom the request is being created
Address	The address where the asset is located
Parent Asset	Any parent asset if available
